1. Summary

This is the Final progress report that summarizes work to date on the project 'Fostering Tenure Security and Resilience of Palestinian Communities through Spatial-Economic Planning Interventions in Area C'. International Peace and Cooperation Center (IPCC) worked closely with the targeted Palestinian communities and the representatives of local government units, with direct support from the Ministry of Local Government (MoLG) and United Nations Human Settlements Programme (UN-Habitat) to follow-up on the technical discussion with the Israeli Civil Administration (ICA) for twenty-five (25) local outline plans, these include: Oqban & Al Mrooj, Za'tara, Khirbet Um Dyouf & Jib elDeeb, Beit Ta'mir, Ar Rafideh, At Tuwani, Khirbet 'Abdallah Al Yunis, Tarqumiya South, Umm Al Lahim, Idhna North, Arab Ar Ramadin & Arab Abu Farda, Khallet Sakariya, Al Khader, Ar Ramadein, As Simiya, Al Mansoura, Wadi Du'oq, Jinsafout, Jit, Harmala, Al Halqum & Al Manshiya, Khirbet An Nahla, Abdullah Ibrahim, Deir Ballout, Kisan.

This project is funded by the European Union and is implemented by IPCC in partnership with UN-Habitat office in Palestine. The Project is collaboratively implemented with the MoLG. The report is covering the period from July 2017 to the 31st of March 2020. This report reflects the Project document, reports progress against the logical framework indicators, and reflects on the risks related to these and other changes relevant to the Project.

During the reporting period of the project, 98 visits and meetings to the targeted communities took place and consultations were made with local councils' representatives, including: discussion of the update in the communities in terms of new buildings, new projects, parcellations and ICA comments. In addition, IPCC team concentrated on updating the action plans and the cost estimates for the 25 local outline plans and to check for the implemented projects according to the action plans.

Several meetings were held with the ICA to discuss the local outline plans, and the most important results of these meetings were obtaining numbers for four local outline plans: As Simiya, Kissan, Wadi Du'oq and Al Mansoura. ICA has also asked for an updated aerial photo and photogrammetric map for each plan prepared before 2016, this applies especially to four local outline plans of Herodiun area (Za'tara, Khirbet Um Dyouf & Jib elDeeb, Beit Ta'mir, Ar Rafideh) because these plans have small areas and we were informed by ICA that they will be in progress if the aerial photos and the photogrammetric maps were updated, the ICA also asked for updating the photogrammetric map for the plans that were published for objection and only needs the final signature for authorization such as Harmaleh, Oqban, Tarqumiya South and Umm Al Lahim. During our meetings with the ICA we were also informed that the plan Khirbet 'Abdallah Al Yunis needs some modification in the Arabic regulation and will be published for authorization, so we did the modification and sent it to the MoLG.

On The Other hand, one of the important results of the meetings with the ICA is scaling down the area of these plans(Al Mansoura, Al Khader, Wadi Du'oq, Kissan, Ar Ramadein, As Simiya, Khirbet An Nahla and Abdullah Ibrahim), as ICA proposed new blue lines (boundaries) for the plans. It has also asked to consider the regional roads' offsets, in order to comply the requirements of the Israeli planning system (MEVAT)¹.

¹ MEVAT: An Israeli System for the plan that deals with the colors, system of providing the plan in terms of layers, and coordination system.

4. Challenges and Constraints

- The authorization process with ICA is moving slowly, as ICA requested new aerial photo for 15 outline plans covering a wider area. ICA also asks for using the Israeli system (Mevat) which means changing the way of drawing all the plans.
- The ICA asks for decreasing the areas of the plans, and will study the plans and share their comments but this takes too much time. In addition, sometimes never happen.
- ICA promise to send the required data but this takes long time.
- Plans are sent to ICA through the General Authority of Civil Affairs (GACA) ahead of each planned meeting. In many times, ICA reports a delay in receiving the plans, where they do not have enough time to study the plans thoroughly.

5. Impact of the planning process

The project has proved the ability of planning to improve the situation on the ground in meeting urgent community needs for running water, secure housing and access to education and healthcare. IPCC has developed action plans for the localities. Action plans priorities infrastructure investment based on a needs' assessment and cost estimates and a key step towards the physical delivery of projects. The plans are coordinated with donors and landowners and include the completed design and planning information necessary to implement the project.

As a result of applying a technical approach to create valid plans for localities, confidence has been built to attract funding for the implementation of projects. Many projects have been carried out by the local and international community adopting a de facto approach; such as, building a local council with a kindergarten and a clinic in Khirbet 'Abdallah Al Yunis funded by EU and rehabilitate and construct internal roads in Idhna funded by EU and Denmark Governorate.

The development of infrastructure, public facilities and residential housing encourages members of the communities to stay in their localities instead of seeking more comfortable lives in bigger urban centers. Additionally, the opportunities for future development and associated employment opportunities afforded by the planning process also motivate the younger generation to stay and work in the localities.

On the other hand, once a land parcel is included in an outline plan, its value increases even before statutory approval. Moreover, the freezing of demolition encourages people to build more houses within the plan boundary; for instance, members of the local communities are also starting to invest their own money to build new houses and facilities encouraged by the degree of protection from demolitions that the outline plans provide.

6. Implementation of the Visibility and Communication Plan

- -In all the visits and meetings at the communities, an introduction was made about the cooperation with MoLG, UN-Habitat and the EU support.
- -IPCC also introduce this project, in many workshop and meetings within other projects for partners and International communities, like ARD initiatives project in Bartaa Area.

- -IPCC presents the project in the exhibition of the EU Jerusalem project in IPCC office.
- -IPCC presents the project to its visitors, international groups and local associations.

Annex 2: Summary of the 25 plans

Harmala- Plan No. 1624- Waiting a Political Decision: The plan has been published in Arabic and Hebrew newspapers for public objection for 60 days by the Central Planning Committee at the ICA, and it is waiting for political decision to be fully authorized. During meetings with the ICA, the ICA has requested to edit the school plan, expand the green area, and update the photogrammetric photo, which have been all done and submitted to the ICA. The ICA also requested some modifications in the regulation and in the plan and we waited them to send us the needed data to do the modifications, but they didn't send. The demolishing orders, the action plan and the cost estimates have been updated, in addition to site visits to the village that have been made in coordination with the community representatives.

Khirbet 'Abdallah Al Yunis- Plan No. 1108/1- Waiting a Political Decision: The plan has been published in Arabic and Hebrew newspapers for public objection for 60 days by the Central Planning Committee in ICA, and it is waiting for political decision to be fully authorized. During meeting with the ICA, the ICA has requested to make some modifications to the plan regulations which have been done by us and submitted to the MOLG which in its side contacted the ICA. Several meetings and site visits have been made to the village to discuss the plan. The local council has been also contacted to update the action plan, the cost estimate and the data of the village.

At Tuwani- Plan No. 1764/2- Waiting a Political Decision: The plan has been published in Arabic and Hebrew newspapers for public objection for 60 days (since January 2014) by the Central Planning Committee in ICA, and it is waiting for political decision to be fully authorized. However, the ICA has requested to update the photogrammetric photo. Local council has been contacted and visited several times to discuss the plan, the demolishing orders, the action plan list, the cost estimate and to update the data of the village.

Tarqumiya South- Plan No. 1786/1- Waiting a Political Decision: The plan has been published in Arabic and Hebrew newspapers for public objection for 60 days (since January 2016) by the Central Planning Committee in ICA, and it is waiting for political decision to move on in the authorization process. ICA call for a meeting to discuss the objections and they will invite us. However, the ICA has requested to update the photogrammetric photo. Local council has been contacted and visited several times to discuss the plan, the demolishing orders, the action plan list, the cost estimate and to update the data of the village.

Umm AI Lahim- Plan No. 1519/1- Waiting the Road Department Decision: The plan has been presented two times to the ICA which has requested to update the photogrammetric photo; because the old one is not accurate and to make sure that there are no buildings inside the roads boundaries. However; all requested plans have been submitted to the ICA, and the plan is waiting for the comments of the roads department. The planning team has visited and contacted the village and met the council, and the demolishing orders, the action plans, the cost estimates and the data of the village have been updated.

Idhna North- Plan No. 1704/1- Waiting the Military Decision: The plan is waiting for the Israeli Military response to include the military area which is full of residential building to the plan because the community doesn't want to proceed with the plan without this area. However, it has been presented several times to the ICA without any progress. On the other hand, the planning team has visited the

village and met the council, and updated the action plan, the cost estimate and the demolishing orders list.

Arab Abu Farda and Arab Ar Ramadin- Plan No. 1286- Waiting Military Decision: The plan is waiting for the Israeli military office response because the plan is behind the separation wall. The planning team has visited the village and met the council, collected data about the demolishing orders and updated the action plan, the cost estimate and the village data.

Al Halqum & Al Manshiya- Plan No. 1650- Not Moving forward in discussion with ICA: The plan has been presented to the ICA, they want to separate the two localities and to decrease the area of the plan. The municipality of Taqu' has been visited to discuss the plan, and they informed us of new buildings in the plan that need survey, so it was decided that they do the survey and send them for us to update the plan but they didn't do it, they also rejected removing the agricultural lands from the plan and decreasing the entrances of the locality. On the other hand, the council has been communicated to collect data about the demolishing orders and the action plan has been updated.

Khallet Sakariya-Plan No. 1648/1- Waiting the Military Decision: The plan has been presented to the ICA and they are preparing another plan for the community. However the locality has been visited to update the action plan and the cost estimate.

Beit Ta'mir -Plan No. 1622/1- Under discussion with ICA: The plan has been presented to the ICA which has requested to update the photogrammetric photo in order to go ahead with the approval process. The planning team has visited the village and met the council several times and submitted him a copy of all the planning package, who informed us that Beit Ta'mir plan is within the responsibility of Za'tara municipality and not Beit Ta'mir local council, whereas Ar Rafideh and Khirbet Um Dyouf & Jib elDeeb are within the responsibility of Beit Ta'mir. On the other hand, the demolishing orders, the action plan and the cost estimates have been updated.

Za'tara- Plan No. 1616/1- Under discussion with ICA: The plan has been presented to the ICA which has requested to update the photogrammetric photo in order to go ahead with the approval process. On the other side, the planning team has visited the village three times and met the council, and the demolishing orders have been updated.

Ar Rafideh – Plan No. 1639/1- Under discussion with ICA: The plan has been presented to the ICA which has requested to update the photogrammetric photo in order to go ahead with the approval process. On the other side, the planning team has visited the village and met the council. The demolishing orders and the action plans have been updated.

Khirbet Um Dyouf & Jib elDeeb- Plan No. 1646/1- Under discussion with ICA: The plan has been presented to the ICA which has requested to update the photogrammetric photo in order to go ahead with the approval process. On the other side, the planning team has visited the village and met the council, and the demolishing orders have been updated.

Oqban & Al Mrooj- Plan No. 1647/1- Under discussion with ICA: The plan has been presented two times to the ICA which has requested to update the photogrammetric photo; because the old one is not accurate and to make sure that there are no buildings inside the roads boundaries. The plan now is waiting for the decision of the Committee of Objections. On the other side, the planning team has contacted the municipality to update the demolishing orders and visited the village several times to discuss the plan and update the action plan.

Jit- Plan No. 1222/1- Under discussion with ICA: The plan has been presented to the ICA without getting any comments. There were discussions on the main entrance of the community but a visit for the transportation engineer has been conducted with the joint services council and they decided for the entrance. However, the parcelation project at the community doesn't take into account the plan, and the community doesn't respect the plan when constructing new buildings so the plan was updated several times upon the parcelation project and upon the new buildings which were surveyed by the council and sent to the planning team. On the other hand, the planning team has visited the village several times to discuss the plan until they gave us their approval on the plan. The action plan, the cost estimates and the demolishing orders have been updated.

Jinsafout- Plan No. 1219/1- Under discussion with ICA: The plan has been presented to the ICA without getting any comments. There were discussions on the main entrance of the community but a visit for the transportation engineer has been conducted with the joint services council and they decided for the entrance. However, the local council has changed several times and so they have new comments, and the community doesn't respect the plan when constructing new buildings so the plan has been updated several times upon the comments of the new local council and upon the new buildings which were surveyed by the council. However the plan is still waiting the approval of the community. On the other hand, the planning team updated the action plan, the cost estimate and the demolishing orders of the locality.

Al Khader Plan No. 1618/1- Under discussion with ICA: The plan has been presented five times to the ICA which has objected to the large area of the plan and showed that there is a plan for the industrial area and objections re. The church lands and the archeological area to the north-west of the plan. Accordingly, the plan has been modified and presented to the municipality. Then to the ICA, again which indicates another archeological area to the south of the plan and that there is a detailed plan for a road south of the plan; therefore, the ICA provided the boundaries that excludes the archeological areas and the church lands. The plan boundaries were updated based on ICA's suggestion, and then shared with the municipality for their approval, who accepted the plan. But when the plan was presented to the ICA, the ICA refused the plan and they still want to decrease the area. On the other hand, the demolishing orders, the action plan and the cost estimate for the locality have been updated.

Abdullah Ibrahim. Plan No. 1643/2- Under discussion with ICA: The plan has been presented to the ICA and got notes regarding roads and the connectivity with Khirbet An Nahleh plan. The planning team has visited the village two times and presented the modified plan to the local council which has approved the updated plan. The plan has been presented again to the ICA and they rejected the large area, and

they will study the plan and share their comments. On the other hand, the planning team has visited the village and met the council, and updated the action plan, the cost estimate and the demolishing orders.

Khirbet An Nahla- Plan No. 1643/1- Under discussion with ICA: The plan has been presented to the ICA and got notes regarding some streets and the connectivity with Abdallah Ibrahim plan. The planning team in turn has visited the village two times and presented the modified plan to the local council which has approved for the edits. The plan has been presented again to the ICA and they rejected the large area of the plan, and told us that they will study the plan and send us border. On the other hand, the planning team has visited the village and met the council, and updated the action plan and the demolishing orders.

Kisan- Plan No. 1625/1- Under discussion with ICA: The plan has been presented four times to the ICA and has gotten a plan number in september 2018. The ICA has objected to the plan large area and building in the regional road offset. The planning team has visited the village four times and met the local council and presented the modified plan according to the ICA notes; the council has approved these edits. Nevertheless, the ICA has objected again the plan area which is still considered large and they will share boundaries to update the plan.

Ar Ramadein- Plan No. 1744/1- Under discussion with ICA: The plan has been presented four times to the ICA which has objected to the plan large area and the distant distribution of the buildings. The planning team has visited the village three times and met the local council and presented the modified plan according to the ICA notes and showed the importance of the plan to protect the buildings; the council has approved the edits in order to go ahead with the discussions with the ICA. Moreover, the demolishing orders and the action plan have been updated in coordination with the local council. Now, the plan is waiting for the ICA notes.

Al Mansoura- Plan No. 1174/1 Under discussion with ICA: The plan was presented four times to the ICA and got a number on june 2019, which has objected to the plan large area and to preparing a plan for this small community; later the ICA shared new boundaries for the plan which scale down the area significantly and so a new plan compromising the ICA and the community boundaries was prepared. The new version of the plan was presented to the local council who made some changes. The plan was updated and is ready to be sent to the ICA. The planning team has visited the village four times and met the local council to discuss the plan and update the action plan and the cost estimate.

Wadi Du'oq- Plan No. 1174- Under discussion with ICA: The plan has been presented four times to the ICA and got number on September 2018, the ICA objected the plan large area and objected preparing a plan for this small community; later the ICA shared new boundaries for the plan which scale down the area significantly and so a new plan compromising the ICA and the community boundaries was prepared. The new version of the plan was presented to the local council who made some changes. The plan was updated and is ready to be sent to the ICA. The planning team has visited the village four times and met the local council to discuss the plan and update the action plan and the cost estimate.

As Simiya – Plan No 1781- Under discussion with ICA: The plan has been presented four times to the ICA and got number on june 2018 which objected the plan large area and building in the regional road offset, in addition to including Alkhirba to the plan. Nevertheless, the ICA will study the plan and provide

the planning team with their notes. On the other hand, the planning team has visited the village and met As Samu' municipality several times to update the action plan and the cost estimate.

Deir Ballout - Under discussion with ICA: The plan has been presented to the ICA. It has been modified in coordination with the municipality during several meetings in the village and it is still waiting for other notes from the municipality, because the parcelation project in the community didn't take into account the outline plan, so the municipality provided the planning team with some parcels to update the plan but still some parcels weren't submitted. On the other the action plan and the cost estimate of the village have been updated.


